With 2000 family units, we are uniquely poised to grow a vibrant and sustainable congregation that honors our past and embraces the future.

As the Director of Finance, you will play a pivotal role in shaping the economic journey of our congregation. You will work collaboratively with our staff, leadership, lay committees, and lead an internal team. You will have an important voice in senior leadership and report to the Executive Director. This full-time, in-person position is open and applications will be considered as received.

# **Key Responsibilities**

#### Budgets, Investments, Financial Analysis, and Reporting

- Partner in developing and ensure implementation of financial policies approved by the Board
- Lead the annual budgeting process by department, collaborating with department heads, the
  Finance Chair (s), and the Treasurer and President (s)
- Prepare and present monthly financial reports, including variance analysis, in partnership with the Finance Chair (S), Treasurer and President (s), develop other reporting tools, data for strategic planning and departmental and organizational protocols
- Oversee the Mishkan Or Foundation investments of \$40 million+ in conjunction with Foundation President (s)
- Manage long-term projections and planning with input from lay partners

#### Revenue/Expense Management

- Oversee and ensure the accurate and timely management of all member and school billing and collections processes, prepared and supported by staff, using ShulCloud & Sage
- Support grant management processes, including tracking, compliance, and reporting
- Collaborate on fundraising initiatives, supporting financial sustainability
- Monitor compliance with licenses, insurance policies, and regulatory filings, ensuring timely renewals. Escalate out-of-budget requests to the Finance Committee, Board when necessary
- Approve expenditures and oversee spending requests ensuring alignment with budgets
- Oversee payroll processing, including onboarding, offboarding, and pay runs
- Manage cash flow and provide financial guidance to staff while monitoring adherence to departmental budgets

#### **Administrative Responsibilities**

- Maintain accurate and secure organizational records, including financial, contracts, permits
- Attend Board of Trustees and relevant committee meetings as needed, supporting decisionmaking with reports and data
- Oversee relationships with selected third-party vendors
- Build and maintain positive relationships with synagogue members and volunteers
- Manage the relationship with our supporting Mishkan Or Foundation leadership, and the Mishkan Or Finance Committee and Audit Committee members.
- Ensure compliance with personnel policies in partnership with HR
- Establish and document departmental procedures, workflow and ensure internal controls

- Leadership: Dedicated to maximizing resources for best and highest use, creating a sustainable future, and comfortable leading that charge. Drive and manage change, including updating systems.

- **Finance Expertise and Coaching:** Skilled in working across an organization at every level to educate and guide finance decision-making.
